FUND DESCRIPTION

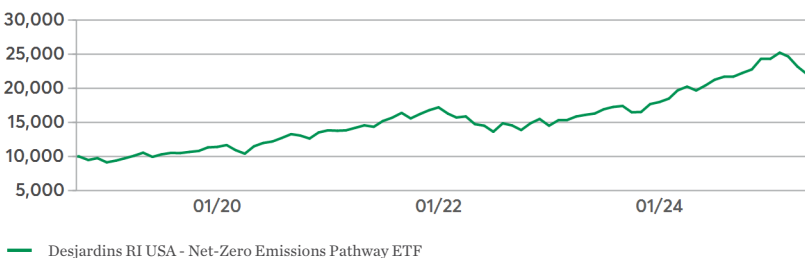

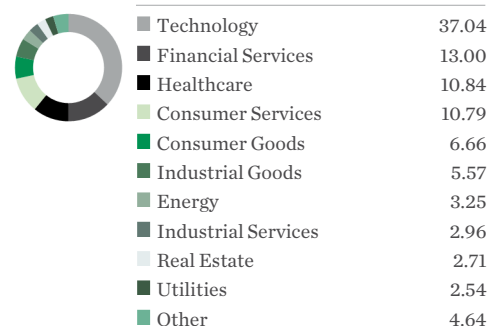
