Major changes to portfolio in the period

- \rightarrow Purchases
 - We increased exposure to the Philippines and Honduras
 - We added to Rwanda and Colombia

 - We exited our positions in Venezuela and Croatia
 - We sold positions in Egypt and Angola
 - We reduced our exposure to Senegal
