Desjardins Investments announces Management fee cuts for 32 Desjardins Funds and changes to the Desjardins Canadian Equity Growth Fund

Montreal, January 17, 2018 – Desjardins Investments Inc. ("DI"), the manager of the Desjardins Funds, announces changes to many Desjardins Funds. These changes are described in details below.

Management fee cuts for 32 Desjardins Funds

DI announced that it will reduce management fee up to 25 basis points for a majority of unit classes of 32 Desjardins Funds, effective January 18, 2018. These changes reflect DI's commitment to provide funds with competitive pricing while providing access to world-class managers.

"The adjustments announced today are consistent with our focus on continually improving our product line, ensuring that our products meet the needs of investors, reflect the realities of today's marketplace and benefit our members and customers," said Sébastien Vallée, General Manager, Investment Solutions Development and Management administrative Department of DI.
